Elected annually – need to be proposed and seconded and confirmed with the person you are nominating. The form then needs to be sent to Secretary, Guy Liddell before Saturday 16 May 2020. All the AGM paperwork will be sent to you by the end of April.

Board of Directors (12)

Elected for a 3-year tenure. Can immediately seek re-election. Places become available each year. Need to be proposed and seconded before the deadline of 16 May 2020 (10 days before the AGM) using the form provided. Copies will be available from the Secretary and website.

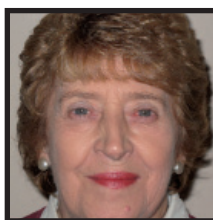

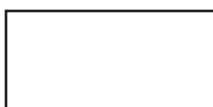
